# Introduction

**TRIMIT Category Management** is a tool to support sales activities on the Standard Out-of-the-Box Webshops and Portals of TRIMIT. It provides users of TRIMIT an easy and familiar approach to publish and maintain Products on their TRIMIT Webshop or Portal.

The Structures build will provide web users a logical and easy navigation to Products.

The Categories can be used for the TRIMIT B2C Webshop, TRIMIT B2B Webshop and TRIMIT Sales Agent Portal based on settings in the **Portal Profiles**.

**The audience for this document is the Consultant or very skilled User. It will only describe the TRIMIT fields/functionality and not the standard Business Central fields/functionality. Be aware of not changing settings and parameters in a live database without consulting the implementing partner.**

The functionality described is the functionality as of **TRIMIT 24.2 for Business Central W1 BC25.X**.

The pictures in this White Paper are based on the demo data for **TRIMIT 24.2**, which is based on Microsoft Dynamics 365 Business Central 2024 Release Wave 2, in the demo company **CRONUS TRIMIT W1 Ltd.** (based on CRONUS International Ltd. of Microsoft Dynamics 365 Business Central).

## Matrix Limitation

Here you can determine that only specific Variants like Colors or Sizes can be used. This means that if you connect a **Matrix Limitation Setup** to a Category, only specific Variants like Colors or Sizes from the connected Masters to a Category will be shown on the portal. I.e.: for a "Summer" Category you only want to see the Colors 100 – 200, for a "Winter" Category you only want to see the Colors 150 – 250.

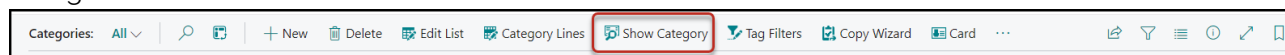

## Do no show on First Level

The list of Categories can grow over time. To help keeping an overview you can hide (Sub-) Categories in the page **trm Category List (6038121)** by selecting this option.

This page will by default always hide Categories with this Field set to *TRUE*.

Click [Show Category](#) or [Related, Show Category](#) or [Actions, Show All Categories](#) to reveal hidden Categories.



To change the view – adjust filters on Category list page again.

This Field does not affect viewing Categories on Portals.

## Alternative Sorting

Instead of the sorting of the Categories according to the Alphabet, you can enter an **Alternative Sorting**, so the Categories in the Category List will be shown according to this **Alternative Sorting**.

This sorting is only related to **Categories** page and does not affect the sorting on Portals. Sorting on Portals can be changed on **Category Lines** page. Change requires running Portals Schedules.

## Customer Club Level

Related to B2C Webshop. **Customer Club Level** can be set on the Category. Available options in this Field are *Level 0 – Level 5*. If **Customer Club Level** is set, then this means that only members of this **Customer Club Level** and members of **Customer Club Level** above can see this Category.

Change requires running Portals Schedules.

## Collection

In this Field you can enter a **Collection No.** that can be applicable for underlying Category Lines of **Type Collection from Category**.

## Tag Filter Group

In this Field, you can enter a **Tag Filter Group** to determine which Tag Filters you would like to see in the Product Overview Page of this specific Category.

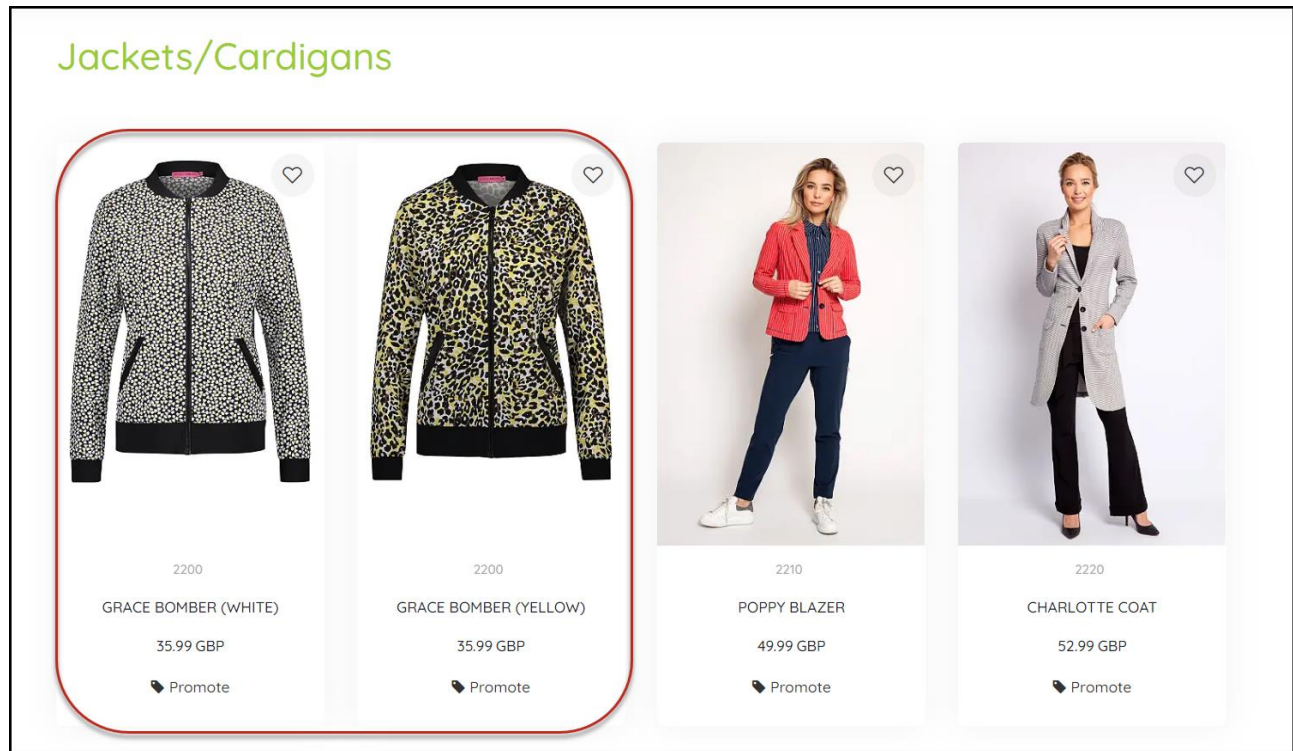
## Expand on Overview

Expanding the Overview means that in the Product Overview Page, not the Masters, but the Masters+First Variant (typically the Colors) will be shown.

You can choose between the following three options:

| Yes       | You want the Product Overview Page to show the Master+First Variant Products. |

## Google Product Taxonomy ID

This Field indicates the unique Product Group number of Google.

I.e., 5622 for Baby & Toddler Outfits or 4355 for Kitchen & Dining Room Tables.

These IDs can be used for Google Analytics. See [Open Google Product Taxonomy](#)

## Category Lines Attached

This Field indicates if there are Category Lines attached to the current Category.

It is automatically updated by the system and non-editable.

## Attached to Category Lines

This Field indicates if this Category is attached to a Parent Category.

It is automatically updated by the system and non-editable.

## Accessories, Complementary Items, Related Bought Items

These Fields are not shown by default; you can add them via **Personalize**.

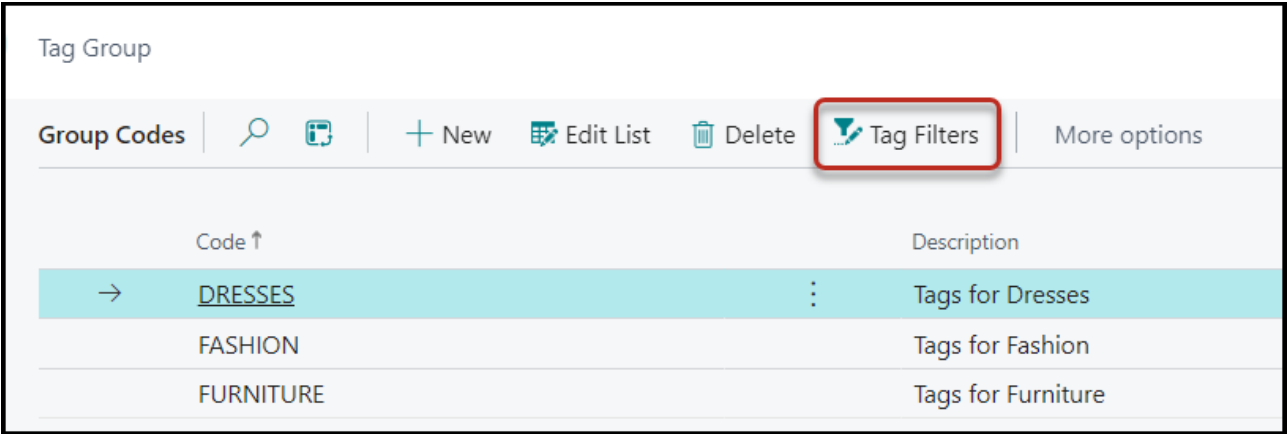
The system will put a checkmark if *Accessories*, *Complementary Items* or *Related Bought Items* have been attached to this Category. See [Type](#) for more details.

## Use CPO Category Buffer

This Field is not shown by default; you can add it via **Personalize**.

Used in connection to data synchronization between TRIMIT and Portals. Set to *TRUE* after running the Action **Pre-Generate Category Data** for the Top-Level Category of the Sales Agent Portal or B2B Webshop, and when running the **Products – Master Choices** Schedule on B2B Webshop.

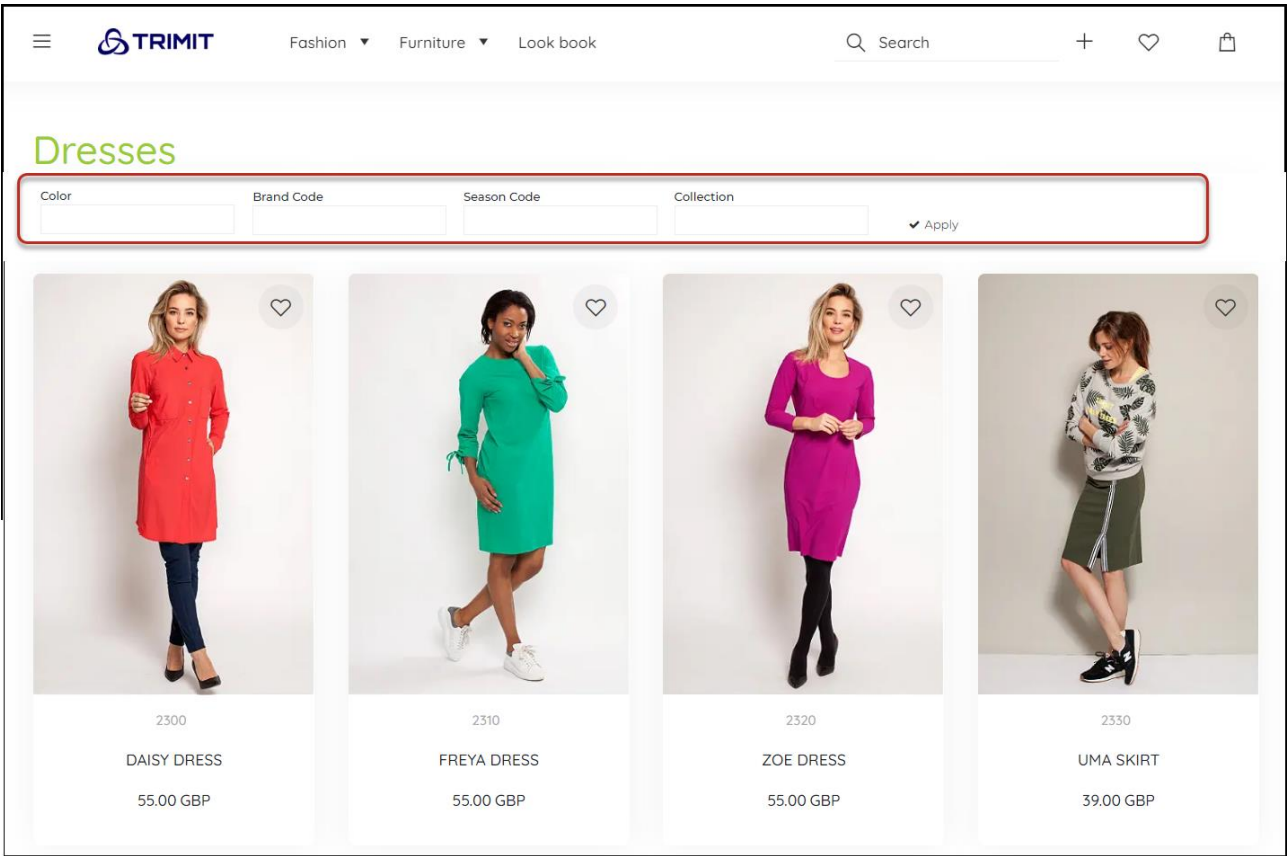

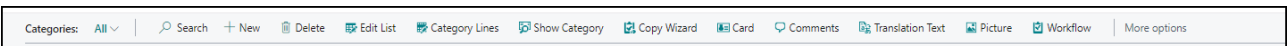
## Sorting

## Show Category

This activity will open a graphical presentation of the Category Structure. Often Structures are under development for some time before being published on the web. This feature will help users to work with Structures without having to check content on any website.

On the **Category Tree View** page, it is possible to show and hide all the subcategories by clicking the **Toggle Expand/Collapse All**, but also on every Line, you can click to **Collapse row** or **Expand row**. Clicking **Related Record** opens the Category card for Categories and the Master-/Item card for Masters or Items.

Clicking **Category Line** opens **Category Lines** page for that specific **Category**.

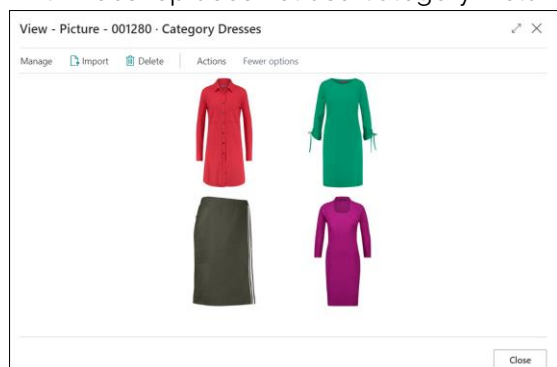
## Comments

## Picture

A Category can have a Picture attached which will be used on TRIMIT Portals. Pictures attached to Categories give a nice "Clickable area" and help the user to understand the content of a Category. Pictures are automatically scaled for web usage. A Category can only hold one Picture. Category Pictures can be applied to Sales Agent Portal and B2B Webshop. B2C Webshop does not use Category Pictures.



## Translation Text

User Language may differ on a web page, and you can create Translations for the Descriptions of the Categories, so they respond to the language rules set by a Portal solution. **Translation Text** will open the **Translated Text Sheet**. In this worksheet, you can specify per **Language Code** the Translation for **Description** and **Description 2**.

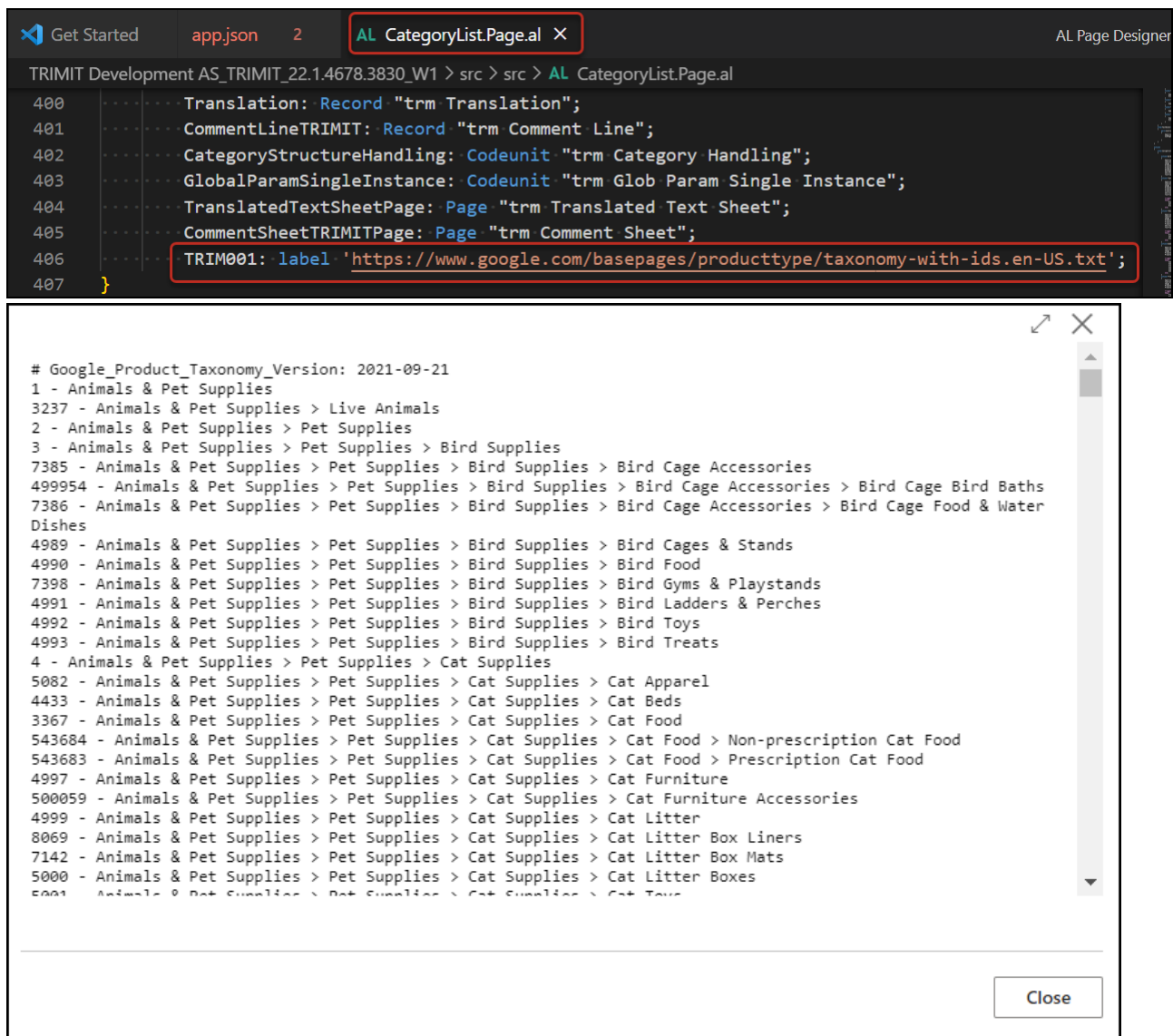

**Note 1**

Be aware that using *Collection*, *Global Dimension* or *Statistics Groups* as a Type on a **Category Line** makes certain restrictions on portals. That is, it will not be possible to use alternative sorting on Master or Item level on the Category which uses Collection, Global Dimension, or Item Statistics group.

**Note 2**

Be aware that portals do not support Items without related Masters: a flat Item should always have a Master.

**No.**

Based on the selected **Type** this Field should be filled and the lookup will show accordingly views. I.e., if the **Type** is set to *Matrix* the lookup is filtering on Masters which have a related Matrix or if the **Type** is set to *User Defined Category* the **No.** is free Text. The different lookups are specified above.

**Matrix Limitation**

This Field will determine which Colors/Sizes/etc. of the Master will be shown on the Portal.

If the **Type** is *Collection*, the **Matrix Limitation** will be filled with the **No.** of the Collection because of the way of filtering the Masters/Colors/Sizes/etc. for the Portals. In that case, the Field **Matrix Limitation Relation** – a Field that is not in the page by default – will also be set correctly to *Collection* and will therefore influence the lookup in the Field **Matrix Limitation**: the list of Collections.

If the **Type** is *Shipment Group*, the **Matrix Limitation** will be filled with the **No.** of the Shipment Group because of the way of filtering the Masters/Colors/Sizes/etc. for the Portals. In that case, the Field **Matrix Limitation Relation** – a Field that is not in the page by default – will also be set correctly to *Shipment Group* and will therefore influence the lookup in the Field **Matrix Limitation**: the list of Shipment Groups.

If the **Type** is not *Collection* or *Shipment Group*, you can enter a **Matrix Limitation Setup**.

I.e.: If the Category is "Summer 2023" the **Matrix Limitation Setup** can determine that only the Colors 100-200 can be used and shown on the Portals for all Masters.

If the Category is "Winter 2023" the **Matrix Limitation Setup** can determine that only the Colors 150-250 can be used and shown on the Portals for all Masters.

This means that you do not have to set the Color filters on every Category Line with a Master individually but can simply enter the **Matrix Limitation Setup** in which you already determined your Filters.

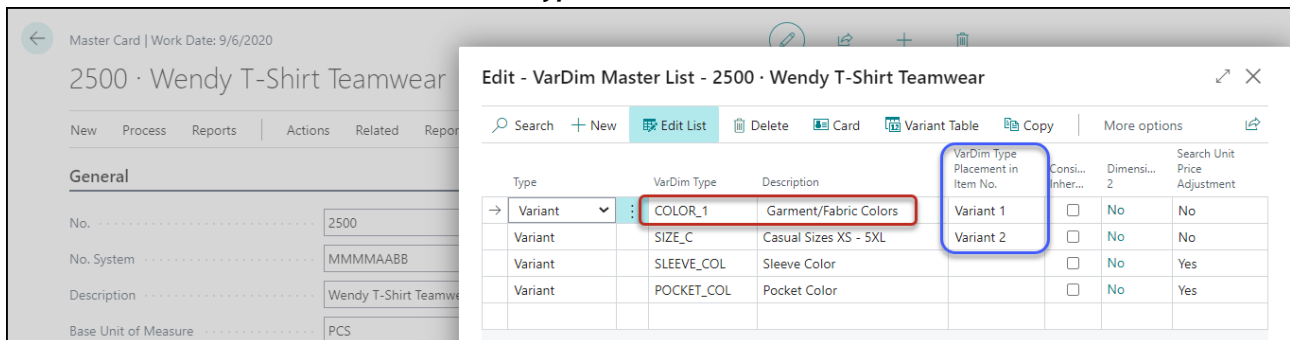

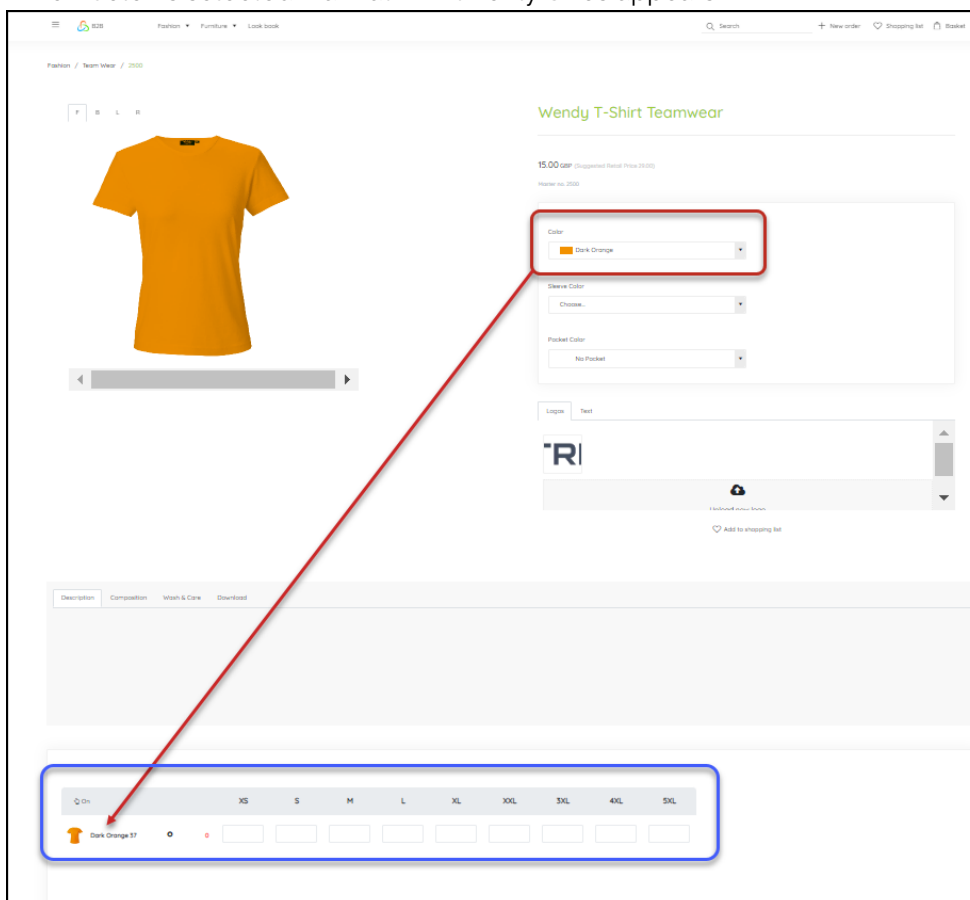

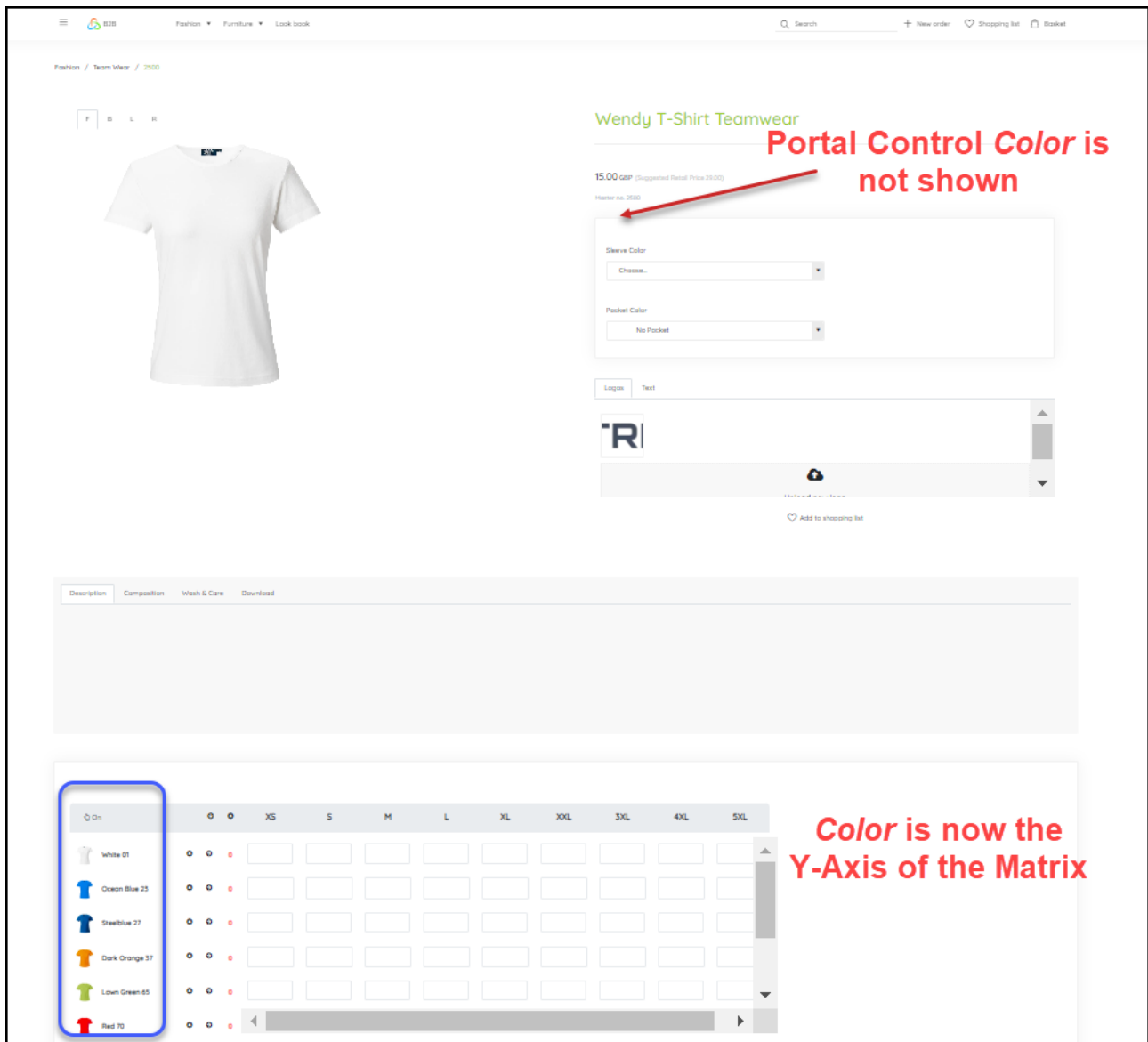

## Allow Bulk Sale on Webshop

Only applicable for the B2C Webshop.

If set to *TRUE*, the B2C User can buy Items via a Matrix instead of buying it by selecting the Variants individually.

## Filter Delivery Period

If **Type** is set to *Collection* and the Collection has differentiated Items for different Delivery Periods, the content can be detailed to showing only Items belonging to the Collection with the chosen filter for Delivery Periods in this Field.

## Category Lines 2

This Field shows if the current Category Line has content on the Next Level.  
It is a non-editable Field and automatically updated by the system.

## Gift Card

Related to B2C Webshop. Should be set to *TRUE* if the Item is a Gift Card. They are handled differently on the Portals as the regular Items.

## Customer Club Level

Related to B2C Webshop. Available options in this Field are *Level 0 – Level 5*.

If **Customer Club Level** is set, then this means that only members of this **Customer Club Level** and members of higher **Customer Club Levels** can see the content this Category Line.

Change requires running Portals Schedules.

## Alternative Sorting

A Category Structure is normally created top down on every Level. However, you can change the order in which the Levels are displayed, simply by applying **Alternative Sorting** values. The Field accepts integers and will sort records ascending.

## Effective Date

In a Structure, you can set individual Lines to only be visible from a given Date. This enables an administrator to work with and create Structures in advance towards an upcoming sales season.

## Expiry Date

A Structure level can have an **Expiry Date** which effectively removes it at runtime if the Date is exceeded.

## Handle Item as

This Field specifies how the Item(s) is presented on a Web page. Also, it will do implicit filtering at runtime. Consider that a Collection holds a Master which has Matrix Relations but the Master itself also represents Items which are the specifics of a Color and Size.

If the Category Line specifies **Handle Item As Matrix**, the Masters themselves are shown.

If set to **Handle Item As Item**, the runtime generation will find all the Items under the related Masters and display these Items in the Category List.

## NOTE

Setting the correct **Handle Item As** is particularly important. Standard TRIMIT Portals will malfunction if an Item or a Master is set to be sold in an illogical manor. If in doubt always test the behavior on the intended Portal.

## Sales Status

With this Field you can determine if this Category Line can be bought on the Portals (*Sellable*) or if it will only show the Products – which cannot be bought yet i.e. (*Only show*).

## Description of the Fields not Visible by Default

These Fields could be added via **Personalize**.

### Parent No.

Shows the Parent Category (Line) in the Structure.

### Description 2

This Field is populated from the selected **No.**, under the same conditions as **Description**.

### Portal Code

Code which the CSS on the Portal page can react upon. The Code is your own choice which you then coordinate with the CSS/HTML developer, who can change the Code in the CSS to react accordingly. Read more in **White Paper – TRIMIT Campaign Customization**.

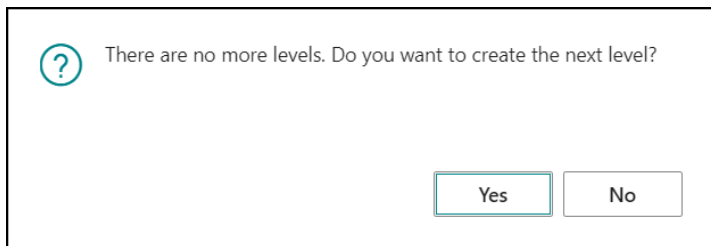

## Picture

A Category Line can have a Picture attached which will be used on TRIMIT Portals. Pictures attached to Category Lines give a nice "Clickable area" and help the user to understand the content of a Category Line.

Pictures are automatically scaled for web usage. A Category Line can only hold one Picture. Category Line Pictures can be applied to Sales Agent portal and B2B Webshop. B2C Webshop does not use Category Pictures.

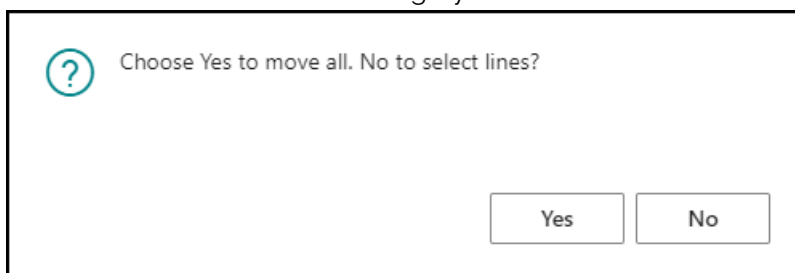

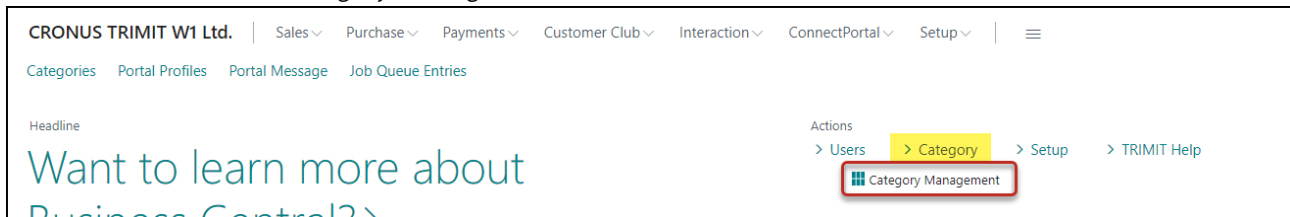

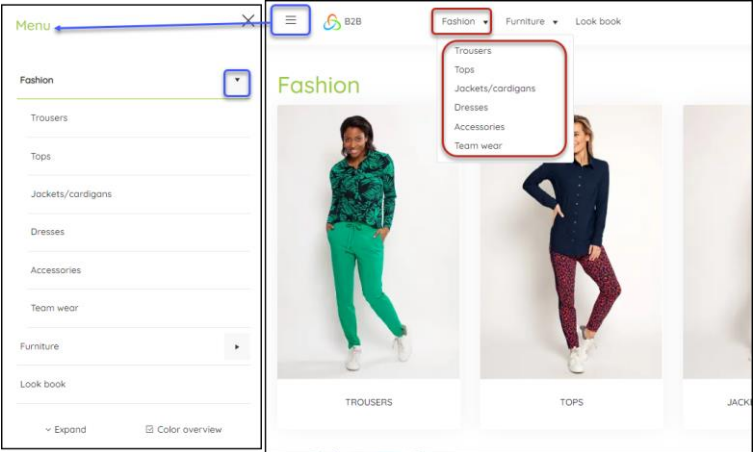

# Attaching a Structure to Users

## Setting up Category Structure for Portals

On standard TRIMIT Portals it is possible to show Categories as a drop-down menu or as a tree menu. This chapter will go through the basic steps for setting this up.



Any Category Structure used on a standard TRIMIT Portal has one important condition that the Top Level (also often called the Root) is not shown. The Top Level is only used for reference when a Structure is attached in various contexts. Consider that if you want to build a specific Category Structure for a Sales Agent Group the Top-Level Category would express the entity relationship rather than the content.

## Filter Items in Portals Categories

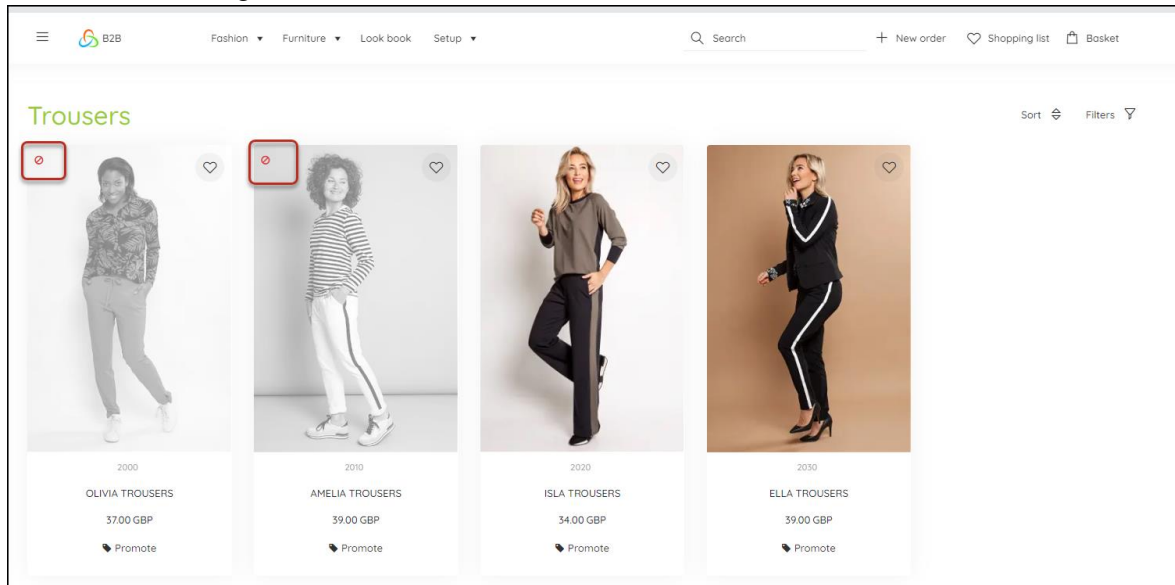
Here is described a way to set a Filter on Items being synchronized with the TRIMIT Portals. If an admin user needs to work with Items on Portal, but these Items should be hidden from ordinary Portal Users, then here is how this can be done in TRIMIT (use one of the approaches):

- Create a new Portal Profile in TRIMIT and attach a new Category Structure to it. The Category Structure should contain Items which must be hidden from ordinary Portal Users. Assign this new Portal Profile to an admin user. Now only admin user will be able to view and work with these specific Items.
- Make needed Masters/Items published or unpublished in Product Information Repository (PIR), in this way they are only visible for admin users.
